The date of execution of Affidavit should be same as date of attestation by the Notary Public / First Class Magistrate.
2. The Affidavit should be signed and affirmed by all the accountholders in the presence of the above Authorities.

In case there is a minor difference in the names of the accountholders on the supporting documents with the one recorded with the Company, kindly add a clause affirming that the name of the accountholder as recorded with the Company and that on the supporting documents pertains to one and the same person.
