- 2** The Non-Judicial Stamp Paper must be purchased in the name of the account holder. The date of execution of Affidavit should be within six months from the date of purchase of Non-Judicial Stamp Paper. The date of execution of Affidavit should be same as date of attestation by the Notary Public / First Class Magistrate.
- 3** The Affidavit should be signed and affirmed by all the account holders in the presence of the above Authorities.
- 4** In case there is a minor difference in the names of the account holders on the supporting documents with the one recorded with the Company, kindly add a clause affirming that the name of the account holder as recorded with the Company and that on the supporting documents pertains to one and the same person.
- 5** Multiple folios will be accepted only if the folios are registered in the same names and in the same order.
